EXAMPLE Troop Annual Budget

UNIT FUNDING PLAN:

- > Scouts pay for the events and activities they participate in. These amounts will vary by campout and activity. SPL tracks this.
- > Troop sells Christmas trees and Scouts must work 3 shifts, but can work more if available.
- > Troop keeps about 30% of the commission with 70% going into each Scouts Account in Scoutbook. Scoutbook.
- > Scouts can participate in Popcorn and Camp Card sales as a way to fund their Scout Account.
- > Scout Account funds can be used for Scouting related purchases such as weekend campouts, summer-camp, NYLT, and uniforms.
